#### HOUSE BILL NO. 6337

## A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license or other authorization; to provide for the forfeiture of firearms under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

by amending sections 5b, 5c, 5d, 5f, 5j, 5l, and 5o (MCL 28.425b, 28.425c, 28.425d, 28.425f, 28.425j, 28.425l, and 28.425o), as added by 2000 PA 381.

#### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5b. (1) To obtain a license to carry a concealed
- 2 pistol, an individual shall apply to the concealed weapon
- 3 licensing board in the county in which that individual resides.

- 1 for a license to carry a concealed pistol. The application
- 2 shall be filed with the county clerk as clerk of the concealed
- 3 weapon licensing board during the county clerk's normal business
- 4 hours. The application shall be on a form provided by the direc-
- 5 tor of the department of state police and shall allow the appli-
- 6 cant to designate whether the applicant seeks a temporary
- 7 license. The application shall be signed under oath by the
- 8 applicant. The oath shall be administered by the county clerk or
- 9 his or her representative. The application shall contain all of
- 10 the following information:
- 11 (a) The applicant's legal name AND date of birth and
- 12 the address of his or her primary residence. If the applicant
- 13 resides in a city, village, or township that has a police depart-
- 14 ment, the information provided under this subdivision shall
- 15 include a statement that the city, village, or township has a
- 16 NAME OF THE police department.
- 17 (b) A statement by the applicant that the applicant meets
- 18 the criteria for a license under this act to carry a concealed
- 19 pistol.
- 20 (c) A statement by the applicant providing authority to
- 21 AUTHORIZING the concealed weapon licensing board to access any
- 22 record, INCLUDING ANY MEDICAL RECORD, pertaining to the
- 23 APPLICANT'S qualifications of an applicant for a license to
- 24 carry a concealed pistol under this act. THE APPLICANT MAY
- 25 REQUEST THAT INFORMATION RECEIVED BY THE CONCEALED WEAPON LICENS-
- 26 ING BOARD UNDER THIS SUBDIVISION BE REVIEWED IN A CLOSED
- 27 SESSION. IF THE APPLICANT REQUESTS THAT THE SESSION BE CLOSED,

- 1 THE CONCEALED WEAPON LICENSING BOARD SHALL CLOSE THE SESSION ONLY
- 2 FOR PURPOSES OF THIS SUBDIVISION. THE APPLICANT AND HIS OR HER
- 3 REPRESENTATIVE HAVE THE RIGHT TO BE PRESENT IN THE CLOSED
- 4 SESSION. INFORMATION RECEIVED BY THE CONCEALED WEAPON LICENSING
- 5 BOARD UNDER THIS SUBDIVISION IS CONFIDENTIAL, IS NOT SUBJECT TO
- 6 DISCLOSURE UNDER THE FREEDOM OF INFORMATION ACT, 1976 PA 442,
- 7 MCL 15.231 TO 15.246, AND SHALL NOT BE DISCLOSED TO ANY PERSON
- 8 EXCEPT FOR PURPOSES OF THIS ACT OR FOR LAW ENFORCEMENT PURPOSES.
- 9 (d) A statement by the applicant regarding whether he or she
- 10 has a history of mental illness that would disqualify him or her
- 11 under subsection  $\frac{(7)(j)}{(7)(1)}$  (7)(I) to (l) from receiving a license
- 12 to carry a concealed pistol, and granting authority to
- 13 AUTHORIZING the concealed weapon licensing board to access the
- 14 mental health records of the applicant relating to his or her
- 15 mental health history. The applicant may request that informa-
- 16 tion received by the concealed weapon licensing board under this
- 17 subdivision be reviewed in a closed session. If the applicant
- 18 requests that the session be closed, the concealed weapon licens-
- 19 ing board shall close the session only for purposes of this
- 20 subdivision. The applicant and his or her representative have
- 21 the right to be present in the closed session. Information
- 22 received by the concealed weapon licensing board under this sub-
- 23 division is confidential, IS NOT SUBJECT TO DISCLOSURE UNDER THE
- 24 FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL 15.231 TO 15.246,
- 25 and shall not be disclosed to any person except for purposes of
- 26 this act OR FOR LAW ENFORCEMENT PURPOSES.

- 1 (e) A statement by the applicant regarding whether he or she
- 2 has ever been convicted in this state or elsewhere for any felony
- 3 or misdemeanor.
- 4 (f) A statement by the applicant whether he or she is HAS
- 5 BEEN dishonorably discharged from the United States armed
- 6 forces.
- 7 (g) If the applicant seeks a temporary license, the facts
- 8 supporting the issuance of that temporary license.
- 9 (h) A statement setting forth the THE names, residential
- 10 addresses, and telephone numbers of 2 individuals who are refer-
- 11 ences for the applicant.
- 12 (i) A passport-quality photograph of the applicant provided
- 13 by the applicant AT THE TIME OF APPLICATION.
- 14 (J) A CERTIFICATE STATING THAT THE APPLICANT HAS COMPLETED
- 15 THE TRAINING COURSE PRESCRIBED BY THIS ACT.
- 16 (2) The application form shall contain a conspicuous warning
- 17 that the application is executed under oath and that intention-
- 18 ally making a material false statement on the application is a
- 19 felony punishable by imprisonment for not more than 4 years or a
- 20 fine of not more than \$2,500.00, or both.
- 21 (3) An individual who intentionally makes a material false
- 22 statement on an application under subsection (1) is guilty of a
- 23 felony punishable by imprisonment for not more than 4 years or a
- 24 fine of not more than \$2,500.00, or both.
- 25 (4) The concealed weapon licensing board shall retain a copy
- 26 of each application for a license to carry a concealed pistol as
- 27 an official record. ONE YEAR AFTER THE EXPIRATION OF A CONCEALED

- 1 PISTOL LICENSE, THE COUNTY CLERK MAY DESTROY THE RECORD AND
- 2 MAINTAIN ONLY A NAME INDEX OF THE RECORD.
- 3 (5) Each applicant shall pay a fee of  $\frac{$55.00}{}$  \$105.00 by
- 4 any method of payment accepted by that county for payments of
- 5 other fees and penalties. , plus an additional assessment of
- 6 \$5.00 for deposit in the concealed weapon enforcement fund under
- 7 section 5v at the time of filing an application under this
- 8 section. A unit of local government, an agency of a unit of
- 9 local government, or an agency or department of this state shall
- 10 not charge an additional fee, assessment, or other amount in con-
- 11 nection with a license under this section. -, other than the fin-
- 12 gerprint fee provided for in this act. The fee and assessment
- 13 shall be payable to the county. The county treasurer shall
- 14 deposit \$\frac{\$10.00}{}\$ \$41.00 of each fee collected under this section
- 15 in the general fund of the county to the credit of the county
- 16 clerk AND CREDIT \$26.00 OF THAT DEPOSIT TO THE CREDIT OF THE
- 17 COUNTY CLERK AND \$15.00 OF THAT DEPOSIT TO THE CREDIT OF THE
- 18 COUNTY SHERIFF and forward the balance to the state treasurer.
- 19 The state treasurer shall deposit the balance of the fee in the
- 20 general fund to the credit of the department of state police.
- 21 The state treasurer shall deposit the assessment in the con-
- 22 cealed weapon enforcement fund created in section 5v. Each
- 23 county shall report to the senate and house fiscal agencies by
- 24 October 1 of each year its costs per applicant to implement this
- 25 section.— THE DEPARTMENT OF STATE POLICE SHALL USE THE MONEY
- 26 RECEIVED UNDER THIS ACT TO PROCESS THE FINGERPRINTS AND TO
- 27 REIMBURSE THE FEDERAL BUREAU OF INVESTIGATION FOR THE COSTS

- 1 ASSOCIATED WITH PROCESSING FINGERPRINTS SUBMITTED UNDER THIS
- 2 ACT. THE BALANCE OF THE MONEY RECEIVED UNDER THIS ACT SHALL BE
- 3 CREDITED TO THE DEPARTMENT OF STATE POLICE.
- 4 (6) The county sheriff on behalf of the concealed weapon
- 5 licensing board shall verify the requirements of subsection
- (7)(d), (e), (f), (h), (i), (j), (k), (l), and (m) through the
- 7 law enforcement information network and report his or her finding
- 8 to the concealed weapon licensing board. If the applicant
- 9 resides in a city, village, or township that has a police depart-
- 10 ment, the concealed weapon licensing board shall contact that
- 11 city, village, or township police department to determine only
- 12 whether that city, village, or township police department has any
- 13 information relevant to the investigation of whether the appli-
- 14 cant is eliqible under this act to receive a license to carry a

- 17 license to an applicant to carry a concealed pistol within the
- 18 period required under this act after the applicant properly sub-
- 19 mits an application under subsection (1) and the concealed weapon
- 20 licensing board determines that all of the following circum-

- 22 (a) The applicant is 21 years of age or older.
- 23 (b) The applicant is a citizen of the United States or is a
- 24 resident legal alien as defined in section 11 of title 18 of the
- 25 United States Code, is a resident of this state, and has resided
- 26 in this state for at least 6 months. The concealed weapon
- 27 licensing board may waive the 6-month residency requirement for a

- 6 (c) The applicant has knowledge and has had training in the
- 7 safe use and handling of a pistol by the successful completion of
- 8 a pistol safety training course or class that meets the require-
- 9 ments of section 5j, and that is available to the general public
- 10 and presented by a law enforcement agency, junior or community
- 11 college, college, or public or private institution or organiza-
- 12 tion or firearms training school.
- 13 (d) The applicant is not the subject of an order or disposi-
- 14 tion under any of the following:
