- 1 Sec. 43510. (1) —A—Subject to subsection (2), a person

- 3 crossbow, or a trap while in any area frequented by wild animals
- 4 unless that person has in his or her possession a license as

- 6 (2) This act or a rule promulgated or order issued by the

- 8 construed to prohibit a person from transporting a pistol or
 - carrying a loaded pistol, whether concealed or not, if either of
