THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) A person who is a resident of this state may
- 2 apply to the department of state for an official state personal
- **3** identification card. Upon application the applicant shall supply
- 4 a birth certificate attesting to his age or other sufficient
- 5 documents or identification as the secretary of state may
- 6 require. The secretary of state shall accept as 1 of the
- 7 required identification documents an identification card issued
- 8 by the department of corrections to prisoners who are placed on
- 9 parole or released from a correctional facility, containing the
