A bill to amend 1961 PA 236, entitled

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 151d. (1) The juror compensation reimbursement fund is created in the state treasury. The money in the fund shall be used as provided in section 151e.
- (2) The state treasurer shall credit to the juror
- 5 compensation reimbursement fund deposits of proceeds from the
- 6 collection of driver license clearance fees as provided in
- 7 section 321a(11) of the Michigan vehicle code, 1949 PA 300,
- 8 MCL 257.321a, and deposits of proceeds from the collection of
- Θ jury demand fees as provided in sections 2529(1)(c) and 8371(9),
