## **HOUSE BILL No. 4536**

March 28, 2007, Introduced by Reps. Angerer, Ebli, Byrum, Donigan, McDowell, Hammon, Warren, Melton, Clack and Simpson and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled

"Michigan vehicle code,"

by amending section 710e (MCL 257.710e), as amended by 1999 PA 29.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 710e. (1) This section does not apply to a driver or
- passenger of any of the following:
- 3 (a) A motor vehicle manufactured before January 1, 1965.
- **4** (b) A bus.
- 5 (c) A motorcycle.
- 6 (d) A moped.
- 7 (e) A motor vehicle if the driver or passenger possesses a 8 written verification from a physician that the driver or passenger
- 9 is unable to wear a safety belt for physical or medical reasons.

- 1 (f) A motor vehicle that is not required to be equipped with
- 2 safety belts under federal law.
- 3 (g) A commercial or United States postal service vehicle that
- 4 makes frequent stops for the purpose of pickup or delivery of goods
- **5** or services.
- 6 (h) A motor vehicle operated by a rural carrier of the United
- 7 States postal service while serving his or her rural postal route.
- 8 (2) This section does not apply to a passenger of a school
- 9 bus.
- 10 (3) Each driver and front seat passenger of a motor vehicle
- 11 operated on a street or highway in this state shall wear a properly
- 12 adjusted and fastened safety belt, except that a child less than 4
- 13 years of age shall be protected as required in section 710d. AS
- 14 FOLLOWS:
- 15 (A) A CHILD LESS THAN 4 YEARS OF AGE SHALL BE PROTECTED AS
- 16 REQUIRED IN SECTION 710D.
- 17 (B) A CHILD WHO IS MORE THAN 4 YEARS OF AGE BUT LESS THAN 9
- 18 YEARS OF AGE AND WEIGHING AT LEAST 40 POUNDS BUT NOT MORE THAN 80
- 19 POUNDS AND A CHILD THAT IS NOT MORE THAN 4 FEET 9 INCHES IN HEIGHT
- 20 SHALL BE SEATED IN A MANUFACTURER CERTIFIED BOOSTER SEAT AND
- 21 SECURED BY A SEAT BELT.
- 22 (4) If there are more passengers than safety belts available
- 23 for use, and all safety belts in the motor vehicle are being
- 24 utilized in compliance with this section, the driver of the motor
- 25 vehicle is in compliance with this section.
- 26 (5) (4)—Each driver of a motor vehicle transporting a child 4
- 27 years of age or more but less than 16 years of age in a motor

- 1 vehicle shall secure the child in a properly adjusted and fastened
- 2 safety belt. If the motor vehicle is transporting more children
- 3 than there are safety belts available for use, all safety belts
- 4 available in the motor vehicle are being utilized in compliance
- 5 with this section, and the driver and all front seat passengers
- 6 comply with subsection (3), then the driver of a motor vehicle
- 7 transporting a child 4 years of age or more but less than 16 years
- 8 of age for which WHOM there is not an available safety belt is in
- 9 compliance with this subsection, if that child is seated in other
- 10 than the front seat of the motor vehicle. However, if that motor
- 11 vehicle is a pickup truck without an extended cab or jump seats,
- 12 and all safety belts in the front seat are being used, the driver
- 13 may transport such a child in the front seat without a safety belt.
- 14 (6) (5) If after December 31, 2005 the office of highway
- 15 safety planning certifies that there has been less than 80%
- 16 compliance with the safety belt requirements of this section during
- 17 the preceding year, then enforcement of this section by state or
- 18 local law enforcement agencies shall be accomplished only as a
- 19 secondary action when a driver of a motor vehicle has been detained
- 20 for a suspected violation of another section of this act.
- 21 (7) (6)—Failure to wear a safety belt in violation of this
- 22 section may be considered evidence of negligence and may reduce the
- 23 recovery for damages arising out of the ownership, maintenance, or
- 24 operation of a motor vehicle. However, such negligence shall not
- 25 reduce the recovery for damages by more than 5%.
- 26 (8) (7)—A person who violates this section is responsible for
- 27 a civil infraction.

- 1 (9) (8) A law enforcement agency shall conduct an
- 2 investigation for all reports of police harassment that result from
- 3 the enforcement of this section.
- 4 (10) (9) The secretary of state shall engage an independent
- 5 organization to conduct a 3-year study to determine the effect that
- 6 the primary enforcement of this section has on the number of
- 7 incidents of police harassment of drivers. The organization that
- 8 conducts the study shall submit a report to the legislature not
- 9 later than June 30, 2001 and an annual report not later than June
- 10 30 each year thereafter.
- 11 (11) <del>(10)</del> The secretary of state shall promote compliance with
- 12 the safety belt requirements of this section at the branch offices
- 13 and through any print or visual media determined appropriate by the
- 14 secretary of state.
- 15 (12) (11) The secretary of state shall conduct a study with
- 16 the cooperation and contribution of the directors of the department
- 17 of state police, the department of community health, the state
- 18 transportation department, and the insurance bureau to analyze the
- 19 monetary savings, if any, arising from the enactment of the
- 20 amendatory act that added this subsection 1999 PA 29. The secretary
- 21 of state shall report the findings of the study to all of the
- 22 following not later than May 1, 2000:
- 23 (a) The senate and house of representatives appropriations
- 24 committees.
- 25 (b) The senate and house of representatives fiscal agencies.
- 26 (13) (12)—It is the intent of the legislature that the
- 27 enforcement of this section be conducted in a manner calculated to

- 1 save lives and not in a manner that results in the harassment of
- 2 the citizens of this state.
- 3 (14) (13) Points shall not be assessed under section 320a for
- 4 a violation of this section.
- 5 Enacting section 1. This amendatory act takes effect April 1,
- 6 2008.
- 7 Enacting section 2. This amendatory act does not take effect
- 8 unless Senate Bill No.\_\_\_\_ or House Bill No. 4538(request no.
- 9 01643'07) of the 94th Legislature is enacted into law.
