A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 2045, 74116, 74117, 74120, 78105, and 78119
(MCL 324.2045, 324.74116, 324.74117, 324.74120, 324.78105, and 324.78119), section 2045 as added by 2010 PA 32, sections 74116, 74117, and 74120 as amended by 2010 PA 33, and section 78105 as amended and section 78119 as added by 2010 PA 34.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2045. (1) The department shall distribute recreation
- passport fee revenue as follows:
- 3 (a) First, for necessary expenses incurred by the secretary of
- 4 state each state fiscal year in administration and implementation
- 5 of section 805 of the Michigan vehicle code, 1949 PA 300, MCL
- 6 257.805. Funds appropriated for necessary expenses shall be based

- 1 upon an established cost allocation methodology that reflects
- 2 actual costs. Appropriations under this subdivision in a state
- 3 fiscal year shall not exceed \$1,000,000.00.
- 4 (b) The next \$10,700,000.00 received each fiscal year shall be
- 5 deposited in the state park improvement account.
- 6 (c) The next \$1,030,000.00 received each fiscal year shall be
- 7 deposited in the waterways account.
- 8 (d) The remaining revenue shall be deposited as follows:
- 9 (i) 50% in the state park improvement account to be used for
- 10 capital improvements at state parks, including state recreation
- 11 areas.
- (ii) 30% in the state park improvement account to be used for
- 13 operations and maintenance at state parks, including state
- 14 recreation areas.
- 15 (iii) 2.75% in the state park improvement account to be used for
- 16 operations, maintenance, and capital improvements of state park
- 17 cultural and historic resources.
- 18 (iv) 0.25% in the state park improvement account to be used to
- 19 do all of the following:
- 20 (A) Promote, in concert with other state agencies, the use of
- 21 state parks, state-operated public boating access sites, state
- 22 forest campgrounds, and state forest nonmotorized trails and
- 23 pathways.
- 24 (B) Promote the use of the internet for state park camping
- 25 reservations and for payment of the recreation passport fee in
- 26 conjunction with motor vehicle registration.
- (v) 10% in the local public recreation facilities fund created

in section 1911, to be used for development of public recreation 1 2 facilities for local units of government. (vi) 7% in the forest recreation account to be used for 3 4 operating, maintaining, and making capital improvements to state forest campgrounds and the state forest system of pathways and 5 nonmotorized trails, including, but not limited to, equestrian 6 7 trails. 8 (2) For each state fiscal year, beginning with the 2011-2012 9 state fiscal year, the state treasurer shall adjust the amounts set forth in subsection (1)(b) and (c) by an amount determined by the 10 11 state treasurer to reflect the cumulative percentage change in the 12 consumer price index for the most recent 1-year period for which data are available. - 5 (7) (5)—The department may prepare a list of frequently asked

- 8 their websites. The department of state may provide the information
- 9 with any applications for registration of motor vehicles that are
- 10 mailed by the department of state.
- 11 Sec. 74116. (1) Subject to subsection (4), the operator of a
- 12 nonresident motor vehicle or commercial motor vehicle shall not
- 13 enter any state park with that motor vehicle unless a valid motor
- 14 vehicle park permit issued under section 74117 is affixed to the
- 15 lower right-hand corner of the windshield. An annual motor vehicle
- 16 park permit for a nonresident motor vehicle shall be affixed
- 17 permanently for that year. The department shall post signs at parks
- 18 that state that a motor vehicle permit is required for entry by a

- 27 (3) Subject to subsection (4), if the secretary of state

- 1 issues registration tabs or stickers as described in section 805 of
- 2 the Michigan vehicle code, 1949 PA 300, MCL 257.805, the operator
- 3 of a resident motor vehicle shall not enter a state park with the
- 4 resident motor vehicle unless the resident motor vehicle has a
- 5 registration tab or sticker or temporary registration plate marked
- 6 as provided under that section to show that the recreation passport
- 7 fee has been paid.
- 8 (4) The requirements of subsections SUBSECTIONS (1) to (3) do
- 9 not apply under any of the following circumstances:
- 10 (a) While the motor vehicle is being driven or parked within
- 11 an established federal, state, or county highway within a state
- **12** park.
- 13 (b) If the motor vehicle is used in the operation or
- 14 maintenance of a state park, is an emergency motor vehicle, is a
- 15 state owned or law enforcement motor vehicle, or is a private motor
- 16 vehicle being operated on official state business.
- 17 (C) IF THE MOTOR VEHICLE IS REGISTERED UNDER SECTION 803E(1)
- 18 OF THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.803E, AND IS
- 19 EXEMPT UNDER SECTION 803E(6) OF THE MICHIGAN VEHICLE CODE, 1949 PA
- 20 300, MCL 257.803E, FROM THE REGISTRATION TAX, OR IF THE MOTOR
- 21 VEHICLE IS REGISTERED UNDER SECTION 217D OR 803F OF THE MICHIGAN
- 22 VEHICLE CODE, 1949 PA 300, MCL 257.217D AND 257.803F.
- 23 (D) (c)—If and to the extent the department waives the
- 24 requirements for department-sponsored events or other circumstances
- 25 as determined by the director or the director's designee.
- 26 Sec. 74117. (1) This subsection and subsections (2) to (9)
- 27 apply beginning October 1, 2010. The department shall prepare and

- 1 distribute park permits as necessary to implement this part.
- 2 (2) Except as otherwise provided in this section, THE
- 3 DEPARTMENT SHALL ISSUE an annual nonresident motor vehicle park
- 4 permit shall be issued and shall authorize THAT AUTHORIZES the
- 5 entry of a nonresident motor vehicle to which it is originally
- 6 attached within any state park during the calendar year for which
- 7 it is issued. The fee for the annual nonresident motor vehicle park
- 8 permit for the owner of a nonresident motor vehicle is \$29.00. An
- 9 annual park permit shall not be used for a commercial motor
- 10 vehicle.
- 11 (3) A—THE DEPARTMENT SHALL ISSUE A daily motor vehicle park
- 12 permit, valid for 1 day only, shall authorize THAT AUTHORIZES the
- 13 entry of a nonresident motor vehicle or commercial motor vehicle to
- 14 which it is originally attached within any state park during the
- 15 day for which it is issued. The fee for a daily nonresident motor
- 16 vehicle park permit is \$8.00. The fee for a daily commercial motor
- 17 vehicle park permit is \$15.00.
- 18 (4) A person who has obtained an annual nonresident motor
- 19 vehicle park permit under this section for a recreational vehicle
- 20 to be used as a stationary primary camping shelter camped legally
- 21 in and not moved from a state park campground during the period of
- 22 the camping stay may obtain a duplicate nonresident motor vehicle
- 23 park permit effective for the duration of the camping stay for a
- 24 towed second motor vehicle present at the time of entry for a fee
- 25 of \$6.00.
- 26 (5) The department may designate persons in this state
- 27 authorized to sell park permits. The department shall require as a

- 1 condition of the designation of a person other than a department
- 2 employee that the person furnish a surety bond in an amount and
- 3 form and with a surety acceptable to the department. After being
- 4 designated by the department, a person may issue park permits in
- 5 accordance with this part. This subsection does not apply to
- 6 employees of the department of state acting under section 805 of
- 7 the Michigan vehicle code, 1949 PA 300, MCL 257.805.
- **8** (6) If a person's annual nonresident motor vehicle park permit
- 9 is lost or destroyed, the department shall provide that person with
- 10 a replacement motor vehicle park permit free of charge. The

- 13 motor vehicle to which it is originally attached within the

- 15 the annual park permit is as follows:
- 16 (a) For the owner of a resident motor vehicle, \$24.00, except
- 17 as follows:
- 18 (i) The fee for the owner of a resident motor vehicle who is 65
- 19 years of age or older is \$6.00.
- 20 (ii) The fee for the owner of a resident motor vehicle who, at
- 21 the time of purchase, is in possession of a food stamp card and
- 22 personal identification is \$18.00.
- 23 (b) For the owner of a nonresident motor vehicle, \$29.00.
- 24 (12) A daily permit, valid for 1 day only, shall authorize the
- 25 entry of the motor vehicle to which it is originally attached
- 26 within the confines of a state park during the day for which it is
- 27 issued. The fee for a daily permit is as follows:

(a) For the owner of a resident motor vehicle, \$6.00. 1 2 (b) For the owner of a nonresident motor vehicle, \$8.00. (13) A person who has obtained an annual motor vehicle permit 3 under this section for a recreational vehicle to be used as a 4 stationary primary camping shelter camped legally in and not moved 5 from a state park campground during the period of the camping stay 6 may obtain a duplicate motor vehicle permit for a towed second 7 motor vehicle present at the time of entry for a fee of \$6.00 8 9 effective for the duration of the camping stay. (14) The department shall provide to the standing committees 10 11 in the senate and house of representatives along with the 12 appropriate budget subcommittees that primarily consider issues 13 pertaining to natural resources an annual report that details the revenue stream generated by the fee structure under this section. 14 15 This report shall be presented not later than December 31 each year and shall include information on the impact of the revenue stream 16 17 on the Michigan state parks endowment fund created in section 35a 18 of article IX of the state constitution of 1963 and provided for in 19 section 74119, the use of the general fund for funding the state 20 park system, and other relevant issues that impact funding needs 21 for the state park system. 22 (15) This part applies only to the entry of motor vehicles 23 into the state parks and to the park permits authorized in this 24 part and does not obviate the necessity of obtaining additional 25 permits for special services or park privileges as previously or 26 subsequently may be required by law or by rules promulgated by the 27 department. The department shall designate each person in the state

- 1 authorized to sell park permits and shall require as a condition of
- 2 the designation of a person other than a department employee that
- 3 the person furnish a surety bond in an amount, in a form, and with
- 4 a surety that is acceptable to the department. After being
- 5 designated by the department, a person may issue park permits in
- 6 accordance with this part.
- 7 (16) Commercial motor coaches or vans with a capacity of more
- 8 than 12 passengers are not eligible to enter a state park with an
- 9 annual park permit. The daily fee to allow commercial motor coaches
- 10 or vans with a capacity of over 12 passengers daily entry into a
- 11 state park is \$15.00.
- 12 (17) The department may add to the cost of a reservation or a
- 13 motor vehicle entrance or camping fee the charges that the state
- 14 incurs because of the use of a credit card.
- 15 (18) If a person's annual park permit is lost or destroyed,
- 16 the department shall provide that person with a replacement park
- 17 permit free of charge. The department may require a person
- 18 requesting a replacement park permit to supply sufficient evidence
- 19 of the loss or destruction of the original park permit.
- 20 (19) As used in this section, "resident motor vehicle" means a
- 21 vehicle that is registered as a motor vehicle in this state.
- 22 Sec. 74120. (1) The department may promulgate rules to
- 23 implement this part.
- 24 (2) The department may promulgate rules providing a method for
- 25 an individual WHOSE MOTOR VEHICLE REGISTRATION EXPIRES ANNUALLY to
- 26 pay a state park and state-operated public boating access site
- 27 recreation passport fee in addition to the method provided for in

- 1 section 805 of the Michigan vehicle code, 1949 PA 300, MCL 257.805.
- 2 The amount of the state park and state-operated public boating
- 3 access site recreation passport fee required to be paid under the A
- 4 method provided for by rule UNDER THIS SUBSECTION shall not exceed
- 5 twice the amount of a state park and state-operated public boating
- 6 access site recreation passport fee paid under the method provided
- 7 for in section 805 of the Michigan vehicle code, 1949 PA 300, MCL
- 8 257.805. However, during 2010, the
- 9 (3) THE DEPARTMENT SHALL PROMULGATE RULES PROVIDING A METHOD
- 10 FOR AN INDIVIDUAL WHOSE MOTOR VEHICLE REGISTRATION DOES NOT EXPIRE
- 11 ANNUALLY AND WHO IS EXEMPT UNDER SECTIONS 74116(4)(C) AND

- 25 (3) A rule promulgated under subsection (2) does not apply
- 26 after April 1, 2014 unless, during at least 1 of the state fiscal
- 27 years ending September 30, 2011, 2012, and 2013, revenue from the

- 2 state under section 2045(1)(a), equals or exceeds \$12,017,514.00.
- 3 Sec. 78105. (1) The department shall have HAS the following
- 4 powers and duties:
- 5 (a) To acquire, construct, and maintain harbors, channels, and
- 6 facilities for vessels in the navigable waters lying within the
- 7 boundaries of this state.
- 8 (b) To acquire, by purchase, lease, gift, or condemnation the
- 9 lands, rights of way, and easements necessary for harbors and
- 10 channels. For the purposes of this subdivision, the department
- 11 shall be considered a state agency under 1911 PA 149, MCL 213.21 to
- **12** 213.25.
- 13 (c) To acquire, by purchase, lease, gift, or condemnation
- 14 suitable areas on shore for disposal of the material from dredging.

- 16 necessary in carrying out this part, including agreements to hold
- 17 and save the United States free from damages due to the
- 18 construction and maintenance by the United States of those works

- (e) To provide for the granting of concessions within the
- 21 boundaries of harbors, so as to furnish the public gas, oil, food,
- 22 and other facilities.
- 23 (f) To represent this state and the governor in dealings with
- 24 the chief of engineers of the United States army and his or her
- 25 authorized agents for the purposes set forth in this part.
- 26 (g) To charge fees for both seasonal and daily moorage at
- 27 state-operated small craft mooring facilities. All revenues derived

- 1 from this source shall be deposited in the waterways account.
- 2 (h) To collect the proceeds from the sale of marine fuel at
- 3 harbors operated by the department. The proceeds from the sales
- 4 shall be credited to the waterways account and used for the
- 5 purchase of marine fuel supplies as may be needed. Any remaining
- 6 revenue from this source not needed for the purchase of marine fuel
- 7 supplies may be expended in the same manner as other funds within

- 23 UNDER SECTION 78105(2) without a valid pass affixed to the lower
- 24 right-hand corner of the windshield. A seasonal pass shall be

- 27 motor vehicle shall not enter a designated state-operated public

- 7 (3) Subject to subsection (4), if the secretary of state
- 8 issues registration tabs or stickers as described in section 805 of
- 9 the Michigan vehicle code, 1949 PA 300, MCL 257.805, the operator
- 10 of a resident motor vehicle shall not enter a designated state-
- 11 operated public boating access site with the resident motor vehicle
- 12 unless the resident motor vehicle has a registration tab or sticker
- 13 or temporary registration plate marked as provided under that
- 14 section to show that the recreation passport fee has been paid.
- 15 (4) The requirements of subsections SUBSECTIONS (1) to (3) do
- 16 not apply under any of the following circumstances:
- 17 (a) If the motor vehicle is used in the operation or

- 1 (C) (b)—If and to the extent the department waives the
- 2 requirements for department-sponsored events or other circumstances
- 3 as determined by the director or the director's designee.
- 4 (5) A person who violates subsection (1), (2), or (3) is
- 5 responsible for a state civil infraction and may be ordered to pay
- 6 a civil fine of not more than \$100.00. A person shall not be cited
- 7 for a violation of both subsections (2) and (3) for the same
- 8 incident.
- 9 (6) In any proceeding for the violation of this part or a rule
- 10 promulgated under this part, if a motor vehicle is found parked in
- 11 a designated state-operated public boating access site, the
- 12 registration plate displayed on the motor vehicle constitutes prima
