SENATE BILL No. 288

April 9, 2013, Introduced by Senators CASPERSON, HILDENBRAND, BOOHER and MEEKHOF and referred to the Committee on Natural Resources, Environment and Great Lakes.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 40103, 40110, 40113a, and 43536a (MCL
324.40103, 324.40110, 324.40113a, and 324.43536a), section 40103 as
amended by 2012 PA 520, section 40110 as added by 1995 PA 57,
section 40113a as amended by 1997 PA 19, and section 43536a as
amended by 2004 PA 545, and by adding section 48703a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 40103. (1) "Game" means any ANIMAL DESIGNATED AS GAME
UNDER SECTION 40110 AND ANY of the following animals but does not
include privately owned cervidae species located on a cervidae
livestock facility registered under the privately owned cervidae
producers marketing act, 2000 PA 190, MCL 287.951 to 287.969:

- 13 (2) "Interim order of the department" means an order of the
- 14 department issued under section 40108.
- 15 (3) "Kind" means an animal's sex, age, or physical
- 16 characteristics.
- 17 (4) "Normal agricultural practices" means generally accepted
- 18 agricultural and management practices as defined by the commission
- 19 of agriculture and rural development.
- 20 (5) "Open season" means the dates during which game may be
- 21 legally taken.
- 22 (6) "Parts" means any or all portions of an animal, including
- 23 the skin, plumage, hide, fur, entire body, or egg of an animal.
- 24 (7) "Protected" or "protected animal" means an animal or kind
- 25 of animal that is designated by the department as an animal that
- 26 shall not be taken.
- 27 (8) "Residence" means a permanent building serving as a

- 1 temporary or permanent home. Residence may include a cottage,
- 2 cabin, or mobile home, but does not include a structure designed
- 3 primarily for taking game, a tree blind, a tent, a recreational or
- 4 other vehicle, or a camper.
- 5 Sec. 40110. (1) Only the legislature OR THE COMMISSION may
- 6 designate a species as game. If an animal is designated under this
- 7 section by the legislature OR COMMISSION as game, then only the
- 8 legislature OR COMMISSION may authorize the establishment of the
- 9 first open season for that animal. ONLY THE LEGISLATURE MAY REMOVE
- 10 A SPECIES FROM THE LIST OF GAME. THE COMMISSION SHALL EXERCISE ITS
- 11 AUTHORITY UNDER THIS SUBSECTION BY ISSUING ORDERS.
- 12 (2) After the legislature OR COMMISSION authorizes the
- 13 establishment of the first open season for game pursuant to this
- 14 section, the department may issue orders pertaining to that animal
- 15 for each of the purposes listed in section 40107.
- Sec. 40113a. (1) The legislature finds and declares that:
- 17 (a) The wildlife populations of the state and their habitat
- 18 are of paramount importance to the citizens of this state.
- 19 (b) The sound scientific management of the wildlife
- 20 populations of the state, including hunting of bear, is declared to
- 21 be in the public interest.
- 22 (c) The sound scientific management of bear populations in
- 23 this state is necessary to minimize human/bear encounters and to
- 24 prevent bears from threatening or harming humans, livestock, and
- 25 pets.
- 26 (2) The commission of natural resources shall have HAS the
- 27 exclusive authority to regulate the taking of game as defined in

- 1 section 40103 in this state. The commission of natural resources
- 2 shall, to the greatest extent practicable, utilize principles of
- 3 sound scientific management in making decisions regarding the
- 4 taking of game. Issuance of orders by the commission of natural
- 5 resources regarding the taking of game shall be made following a
- 6 public meeting and an opportunity for public input. Not less than
- 7 30 days before issuing an order, the commission of natural
- 8 resources shall provide a copy of the order to each of the
- 9 following:
- 10 (a) Each member of each standing committee of the senate or
- 11 house of representatives that considers legislation pertaining to
- 12 conservation, the environment, natural resources, recreation,
- 13 tourism, or agriculture.
- 14 (b) The chairperson of the senate appropriations committee and
- 15 the chairperson of the house of representatives appropriations
- 16 committee.
- 17 (c) The members of the subcommittee of the senate
- 18 appropriations committee and the subcommittee of the house of
- 19 representatives appropriations committee that consider the budget
- 20 of the department of natural resources.
- 21 (3) FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2013, THERE IS
- 22 APPROPRIATED FOR THE DEPARTMENT THE SUM OF \$1,000,000.00 TO
- 23 IMPLEMENT MANAGEMENT PRACTICES FOR FISH AND GAME ANIMALS, AND
- 24 PERFORM RESEARCH, EDUCATION, AND OUTREACH RELATED TO HUNTING,
- 25 FISHING, GAME ANIMALS, PREDATORS, AND PREY. ANY PORTION OF THE
- 26 AMOUNT UNDER THIS SECTION THAT IS NOT EXPENDED IN THE FISCAL YEAR
- 27 ENDING SEPTEMBER 30, 2013 SHALL NOT LAPSE TO THE GENERAL FUND BUT

- 1 SHALL BE CARRIED FORWARD IN A WORK PROJECT ACCOUNT THAT IS IN
- 2 COMPLIANCE WITH SECTION 451A OF THE MANAGEMENT AND BUDGET ACT, 1984
- 3 PA 431, MCL 18.1451A.
- 4 Sec. 43536a. (1) A—SUBJECT TO ANY LOTTERY AND OTHER
- 5 ELIGIBILITY REQUIREMENTS, A member of the military may obtain any
- 6 license under this part for which a lottery is not required for
- 7 \$1.00 FREE OF CHARGE upon presentation to a licensing agent of
- 8 leave papers, duty papers, military orders, or other evidence
- 9 acceptable to the department verifying that he or she is stationed
- 10 outside of this state. The license is valid for a period of up to 2
- 11 weeks designated by the member of the military but only during the
- 12 season in which such a license would otherwise be valid.A MEMBER OF
- 13 THE MILITARY.
- 14 (2) As used in this section, "member of the military" means
- 15 either of the following:
- 16 (a) A person described by section 43506(3)(d). who is
- 17 stationed outside this state.
- (b) A person who meets all of the following requirements:
- 19 (i) The person is a reserve component soldier, sailor, airman,
- 20 or marine or member of the Michigan national guard and is called to
- 21 federal active duty.
- 22 (ii) At the time the person was called to federal active duty,
- 23 he or she was a resident of this state.
- 24 (iii) The person is stationed outside this state.
- 25 (iii) (iv)—The person has maintained his or her residence in this
- 26 state for the purpose of obtaining a driver license or voter
- 27 registration, or both.

- 1 SEC. 48703A. THE COMMISSION HAS THE EXCLUSIVE AUTHORITY TO
- 2 REGULATE THE TAKING OF FISH IN THIS STATE. THE COMMISSION SHALL, TO
- 3 THE GREATEST EXTENT PRACTICABLE, UTILIZE PRINCIPLES OF SOUND
- 4 SCIENTIFIC MANAGEMENT IN MAKING DECISIONS REGARDING THE TAKING OF
- 5 FISH. THE COMMISSION SHALL ISSUE ORDERS REGARDING THE TAKING OF
- 6 FISH FOLLOWING A PUBLIC MEETING AND AN OPPORTUNITY FOR PUBLIC
- 7 INPUT. NOT LESS THAN 30 DAYS BEFORE ISSUING AN ORDER, THE
- 8 COMMISSION SHALL PROVIDE A COPY OF THE ORDER TO EACH OF THE
- 9 FOLLOWING:
- 10 (A) EACH MEMBER OF EACH STANDING COMMITTEE OF THE SENATE OR
- 11 HOUSE OF REPRESENTATIVES THAT CONSIDERS LEGISLATION PERTAINING TO
- 12 CONSERVATION, THE ENVIRONMENT, NATURAL RESOURCES, RECREATION,
- 13 TOURISM, OR AGRICULTURE.
- 14 (B) THE CHAIRPERSON OF THE SENATE APPROPRIATIONS COMMITTEE AND
- 15 THE CHAIRPERSON OF THE HOUSE OF REPRESENTATIVES APPROPRIATIONS
- 16 COMMITTEE.
- 17 (C) THE MEMBERS OF THE SUBCOMMITTEE OF THE SENATE
- 18 APPROPRIATIONS COMMITTEE AND THE SUBCOMMITTEE OF THE HOUSE OF
- 19 REPRESENTATIVES APPROPRIATIONS COMMITTEE THAT CONSIDER THE BUDGET
- 20 OF THE DEPARTMENT OF NATURAL RESOURCES.
