THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 72105. (1) The department may operate and maintain a
- 2 trail that is located on state owned land or may enter into an
- 3 agreement with a council or 1 or more governmental agencies to
- 4 provide for the operation and maintenance of the trail. An
- 5 agreement entered into under this subsection may include provisions
- 6 for any of the following:
- 7 (a) Construction, maintenance, and operation of the trail.
- 8 (b) Enforcement of trail rules and regulations including
- 9 permitted uses of the trail.

- 1 (c) Other provisions consistent with this part.
- 2 (2) ALL OF THE FOLLOWING APPLY TO THE OPERATION OF AN ELECTRIC
- 3 BICYCLE ON A TRAIL SUBJECT TO THIS PART:
- 4 (A) AN INDIVIDUAL MAY OPERATE A CLASS 1 ELECTRIC BICYCLE ON A
- 5 LINEAR TRAIL THAT HAS AN ASPHALT, CRUSHED LIMESTONE, OR SIMILAR
- 6 SURFACE, OR A RAIL TRAIL. A LOCAL AUTHORITY OR AGENCY OF THIS STATE
- 7 HAVING JURISDICTION OVER A TRAIL DESCRIBED IN THIS SUBDIVISION MAY
- 8 REGULATE OR PROHIBIT THE OPERATION OF A CLASS 1 ELECTRIC BICYCLE ON
- 9 THAT TRAIL.
- 10 (B) AN INDIVIDUAL MAY OPERATE A CLASS 2 OR CLASS 3 ELECTRIC
- 11 BICYCLE ON A LINEAR TRAIL THAT HAS AN ASPHALT, CRUSHED LIMESTONE,
- 12 OR SIMILAR SURFACE, OR A RAIL TRAIL IF AUTHORIZED BY THE LOCAL
- 13 AUTHORITY OR AGENCY OF THIS STATE HAVING JURISDICTION OVER THE
- 14 TRAIL.
- 15 (C) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBDIVISION, AN
- 16 INDIVIDUAL SHALL NOT OPERATE AN ELECTRIC BICYCLE ON A TRAIL THAT IS
- 17 SPECIFICALLY DESIGNATED AS NONMOTORIZED AND THAT HAS A NATURAL
- 18 SURFACE TREAD THAT IS MADE BY CLEARING AND GRADING THE NATIVE SOIL
- 19 WITH NO ADDED SURFACING MATERIALS. A LOCAL AUTHORITY OR AGENCY OF
- 20 THIS STATE HAVING JURISDICTION OVER A TRAIL DESCRIBED IN THIS
- 21 SUBDIVISION MAY ALLOW THE OPERATION OF AN ELECTRIC BICYCLE ON THAT
- 22 TRAIL.
- 23 (3) SUBSECTION (2) DOES NOT APPLY TO THE USE OF ELECTRIC
- 24 BICYCLES ON A CONGRESSIONALLY AUTHORIZED PUBLIC TRAIL SYSTEM.
- 25 (4) AS USED IN THIS SECTION, "ELECTRIC BICYCLE", "CLASS 1
- 26 ELECTRIC BICYCLE", "CLASS 2 ELECTRIC BICYCLE", AND "CLASS 3
- 27 ELECTRIC BICYCLE" MEAN THOSE TERMS AS DEFINED IN SECTION 13E OF THE

- MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.13E. 1
- Enacting section 1. This amendatory act takes effect 90 days 2
- 3 after the date it is enacted into law.
