SENATE SUBSTITUTE FOR HOUSE BILL NO. 5408

A bill to amend 1951 PA 51, entitled

"An act to provide for the classification of all public roads, streets, and highways in this state, and for the revision of that classification and for additions to and deletions from each classification; to set up and establish the Michigan transportation fund; to provide for the deposits in the Michigan transportation fund of specific taxes on motor vehicles and motor vehicle fuels; to provide for the allocation of funds from the Michigan transportation fund and the use and administration of the fund for transportation purposes; to promote safe and efficient travel for motor vehicle drivers, bicyclists, pedestrians, and other legal users of roads, streets, and highways; to set up and establish the truck safety fund; to provide for the allocation of funds from the truck safety fund and administration of the fund for truck safety purposes; to set up and establish the Michigan truck safety commission; to establish certain standards for road contracts for certain businesses; to provide for the continuing review of transportation needs within the state; to authorize the state transportation commission, counties, cities, and villages to borrow money, issue bonds, and make pledges of funds for transportation purposes; to authorize counties to advance funds for the payment of deficiencies necessary for the payment of bonds issued under this act; to provide for the limitations, payment, retirement, and security of the bonds and pledges; to provide for appropriations and tax levies by counties and townships for county roads; to authorize contributions by townships for county roads; to provide for the establishment and administration of the state trunk line fund, local bridge fund, comprehensive transportation fund, and

certain other funds; to provide for the deposits in the state trunk line fund, critical bridge fund, comprehensive transportation fund, and certain other funds of money raised by specific taxes and fees; to provide for definitions of public transportation functions and criteria; to define the purposes for which Michigan transportation funds may be allocated; to provide for Michigan transportation fund grants; to provide for review and approval of transportation programs; to provide for submission of annual legislative requests and reports; to provide for the establishment and functions of certain advisory entities; to provide for conditions for grants; to provide for the issuance of bonds and notes for transportation purposes; to provide for the powers and duties of certain state and local agencies and officials; to provide for the making of loans for transportation purposes by the state transportation department and for the receipt and repayment by local units and agencies of those loans from certain specified sources; and to repeal acts and parts of acts,"

by amending section 9a (MCL 247.659a), as amended by 2012 PA 298.

- 22 (2) In order to provide a coordinated, unified effort by the
- 23 various roadway ROAD agencies within the THIS state, the
- 24 transportation asset management council is hereby created within

- 26 UPON CREATION OF THE MICHIGAN INFRASTRUCTURE COUNCIL, THE

(6) (4) The department shall provide qualified administrative 1 2 staff and the state planning and development regions shall provide qualified technical assistance to the TRANSPORTATION ASSET 3 4 MANAGEMENT council. (5) The council shall develop and present to the state 5 transportation commission for approval within 90 days after the 6 date of the first meeting the procedures and requirements that are 7 necessary for the administration of the asset management process. 8 9 The procedures and requirements developed and presented by the council shall, at a minimum, include the areas of training, data 10 11 storage and collection, reporting, development of a multiyear 12 program, budgeting and funding, and other issues related to asset 13 management. All quality control standards and protocols shall, at a 14 minimum, be consistent with existing federal requirements and regulations and existing government accounting standards. 15 (6) The council may appoint a technical advisory panel whose 16 members shall be representatives from the transportation 17 construction associations and related transportation road 18 19 interests. The asset management council shall select members to the 20 technical advisory panel from names submitted by the transportation 21 construction associations and related transportation road 22 interests. The technical advisory panel members shall be appointed 23 for 3 years. The asset management council shall determine the 24 research issues and assign projects to the technical advisory panel 25 to assist in the development of statewide policies. The technical 26 advisory panel's recommendations shall be advisory only and are not 27 binding on the asset management council.

- 25 (D) ANTICIPATED REVENUES AND EXPENSES, INCLUDING A DESCRIPTION
- 26 OF ALL REVENUE SOURCES AND ANTICIPATED RECEIPTS FOR THE PERIOD
- 27 COVERED BY THE ASSET MANAGEMENT PLAN AND EXPECTED INFRASTRUCTURE

- 1 REPAIR AND REPLACEMENT EXPENDITURES, INCLUDING PLANNED IMPROVEMENTS
- 2 AND CAPITAL RECONSTRUCTION.
- 3 (E) PERFORMANCE OUTCOMES, INCLUDING A DETERMINATION OF HOW THE
- 4 LOCAL ROAD AGENCY'S INVESTMENT STRATEGY WILL ACHIEVE THE DESIRED
- 5 LEVELS OF SERVICE AND PERFORMANCE GOALS AND THE STEPS NECESSARY TO
- 6 ENSURE ASSET CONDITIONS MEET OR ACHIEVE STATED GOALS AND A
- 7 DESCRIPTION AND EXPLANATION OF ANY GAP BETWEEN ACHIEVABLE CONDITION
- 8 AND PERFORMANCE THROUGH THE INVESTMENT STRATEGY AND DESIRED GOALS.
- 9 (F) A DESCRIPTION OF ANY PLANS OF THE ASSET OWNER TO
- 10 COORDINATE WITH OTHER ENTITIES, INCLUDING NEIGHBORING JURISDICTIONS
- 11 AND UTILITIES, TO MINIMIZE DUPLICATION OF EFFORT REGARDING
- 12 INFRASTRUCTURE PRESERVATION AND MAINTENANCE.
- 13 (G) PROOF OF ACCEPTANCE, CERTIFICATION, OR ADOPTION BY THE
- 14 LOCAL ROAD AGENCY'S GOVERNING BODY.
- 15 (11) (7) The department, each county road commission, and each
- 16 city and village of this state shall annually submit a report ON
- 17 INFRASTRUCTURE CONDITIONS AND INVESTMENT to the transportation
- 18 asset management council. This report shall include a multiyear
- 19 program developed through the asset management process described in
- 20 this section. NO LATER THAN OCTOBER 1, 2019, THE TRANSPORTATION
- 21 ASSET MANAGEMENT COUNCIL SHALL ESTABLISH A SCHEDULE FOR THE

- 9 (C) PROJECTS CONTAINED IN THE ANNUAL MULTIYEAR PROGRAM OF EACH
- 10 LOCAL ROAD AGENCY RESPONSIBLE FOR LESS THAN 100 CERTIFIED MILES OF
- 11 ROAD SHALL BE CONSISTENT WITH THE ASSET MANAGEMENT PROCESS OF THAT
- 12 LOCAL ROAD AGENCY AND SHALL BE REPORTED CONSISTENT WITH CATEGORIES
- 13 ESTABLISHED BY THE TRANSPORTATION ASSET MANAGEMENT COUNCIL.
- 14 (12) BEGINNING OCTOBER 1, 2020, EACH LOCAL ROAD AGENCY
- 15 DESCRIBED IN SUBSECTION (11)(B) SHALL BEGIN SUBMITTING AN ASSET
- 16 MANAGEMENT PLAN TO THE TRANSPORTATION ASSET MANAGEMENT COUNCIL
- 17 ACCORDING TO THE 3-YEAR SCHEDULE DESCRIBED IN SUBSECTION (10). THE
- 18 ASSET MANAGEMENT PLAN SHALL COVER A PERIOD OF AT LEAST 3 YEARS, AND

- 26 SHALL COMPLY WITH THIS SUBSECTION WITHIN 120 DAYS OF THE NOTICE. IF
- 27 A LOCAL ROAD AGENCY FAILS TO COMPLY WITH THIS SUBSECTION AFTER 120

- 1 DAYS OF THE NOTICE REQUIRED BY THIS SUBSECTION, THE TRANSPORTATION
- 2 ASSET MANAGEMENT COUNCIL SHALL NOTIFY THE DEPARTMENT OF THE
- 3 NONCOMPLIANCE AND THE DEPARTMENT MAY WITHHOLD FUNDS DISTRIBUTED TO
- 4 THE LOCAL ROAD AGENCY UNDER THIS ACT. THE DEPARTMENT SHALL RELEASE
- 5 ANY FUNDS WITHHELD FOR NONCOMPLIANCE WITH THIS SUBSECTION TO THE
- 6 LOCAL ROAD AGENCY IN THE FOLLOWING MONTH'S ALLOCATION AFTER
- 7 COMPLIANCE IS VERIFIED.
- 8 (13) THE TRANSPORTATION ASSET MANAGEMENT COUNCIL SHALL REVIEW
- 9 AN ASSET MANAGEMENT PLAN SUBMITTED UNDER SUBSECTION (12) NO LATER
- 10 THAN 6 MONTHS AFTER RECEIPT OF THE ASSET MANAGEMENT PLAN. THE
- 11 TRANSPORTATION ASSET MANAGEMENT COUNCIL SHALL COMPARE THE ASSET
- 12 MANAGEMENT PLAN TO THE MINIMUM REQUIREMENTS OF THIS ACT AND THE
- 13 TEMPLATE CREATED BY THE TRANSPORTATION ASSET MANAGEMENT COUNCIL,
- 14 AND DETERMINE WHETHER THE ASSET MANAGEMENT PLAN IS IN COMPLIANCE
- 15 WITH THOSE STANDARDS. IF THE ASSET MANAGEMENT PLAN DOES NOT MEET
- 16 THOSE STANDARDS, THE TRANSPORTATION ASSET MANAGEMENT COUNCIL SHALL
- 17 SEEK CONCURRENCE FROM THE DEPARTMENT THAT THE ASSET MANAGEMENT PLAN
- 18 DOES NOT MEET THE TRANSPORTATION ASSET MANAGEMENT COUNCIL'S
- 19 STANDARDS. IF THE DEPARTMENT CONCURS, THE TRANSPORTATION ASSET

- 21 ITS ASSET MANAGEMENT PLAN TO CONFORM TO THE STANDARDS WITHIN 6
- 22 MONTHS AFTER NOTIFYING THE LOCAL ROAD AGENCY THAT THE ASSET
- 23 MANAGEMENT PLAN DOES NOT MEET THE TRANSPORTATION ASSET MANAGEMENT
- 24 COUNCIL'S STANDARDS. THE TRANSPORTATION ASSET MANAGEMENT COUNCIL
- 25 SHALL PROVIDE AN OPPORTUNITY FOR A NONCOMPLIANT LOCAL ROAD AGENCY
- 26 TO APPEAR BEFORE THE TRANSPORTATION ASSET MANAGEMENT COUNCIL TO
- 27 DISCUSS THE REASONS THE LOCAL ROAD AGENCY'S PLAN IS NOT IN

- 1 COMPLIANCE AND WAYS FOR THE LOCAL ROAD AGENCY TO BECOME COMPLIANT.
- 2 (14) BEGINNING OCTOBER 1, 2025, IF THE TRANSPORTATION ASSET
- 3 MANAGEMENT COUNCIL DETERMINES, AND THE DEPARTMENT CONCURS, THAT A
- 4 LOCAL ROAD AGENCY DESCRIBED IN SUBSECTION (11)(B) HAS NOT
- 5 DEMONSTRATED PROGRESS TOWARD ACHIEVING THE CONDITION GOALS
- 6 DESCRIBED IN ITS ASSET MANAGEMENT PLAN FOR ITS FEDERAL-AID ELIGIBLE
- 7 COUNTY PRIMARY ROAD SYSTEM OR CITY MAJOR STREET SYSTEM, AS
- 8 APPLICABLE, THE TRANSPORTATION ASSET MANAGEMENT COUNCIL SHALL
- 9 PROVIDE NOTICE TO THE LOCAL ROAD AGENCY OF THE REASONS THAT IT HAS
- 10 DETERMINED PROGRESS IS NOT BEING MADE AND RECOMMENDATIONS ON HOW TO

- 25 MAY SHIFT FUNDS DISTRIBUTED TO IT UNDER THIS ACT FROM A COUNTY
- 26 PRIMARY ROAD SYSTEM TO A COUNTY LOCAL ROAD SYSTEM OR FROM A CITY
- 27 MAJOR STREET SYSTEM TO A CITY LOCAL STREET SYSTEM, AS APPLICABLE. A

- 1 LOCAL ROAD AGENCY MAY SUBMIT A REVISED ASSET MANAGEMENT PLAN TO THE
- 2 TRANSPORTATION ASSET MANAGEMENT COUNCIL.
- 3 (15) AN ANNUAL REPORT SHALL BE PREPARED BY THE STAFF ASSIGNED
- 4 TO THE TRANSPORTATION ASSET MANAGEMENT COUNCIL REGARDING THE
- 5 RESULTS OF ACTIVITIES CONDUCTED DURING THE PRECEDING YEAR AND THE
- 6 EXPENDITURE OF FUNDS RELATED TO THE PROCESSES AND ACTIVITIES
- 7 IDENTIFIED BY THE MICHIGAN INFRASTRUCTURE COUNCIL. THE REPORT SHALL
- 8 ALSO INCLUDE A SUMMARY ANALYSIS OF THE ASSET MANAGEMENT PLANS AND
- 9 ANNUAL REPORTS RECEIVED FROM LOCAL ROAD AGENCIES, A DETERMINATION
- 10 OF HOW INVESTMENTS ARE ACHIEVING DESIRED LEVELS OF SERVICE AND
- 11 PERFORMANCE GOALS, AN IDENTIFICATION OF ANY ADDITIONAL STEPS THAT
- 12 MAY BE NEEDED TO ACHIEVE DESIRED LEVELS OF SERVICE AND PERFORMANCE
- 13 GOALS, AND AN OVERVIEW OF THE ACTIVITIES IDENTIFIED FOR THE
- 14 SUCCEEDING YEAR. THE TRANSPORTATION ASSET MANAGEMENT COUNCIL SHALL
- 15 SUBMIT THIS REPORT TO THE MICHIGAN INFRASTRUCTURE COUNCIL, THE
- 16 STATE TRANSPORTATION COMMISSION, THE LEGISLATURE, AND THE

- 4 council. Each local road agency and the department shall annually
- 5 report to the TRANSPORTATION ASSET MANAGEMENT council the mileage
- 6 and condition of the road and bridge system under their
- 7 jurisdiction and the receipts and disbursements of road and street
- 8 funds in the manner prescribed by the TRANSPORTATION ASSET
- 9 MANAGEMENT council, which shall be consistent with any current
- 10 accounting procedures. An annual report shall be prepared by the
- 11 staff assigned to the council regarding the results of activities
- 12 conducted during the preceding year and the expenditure of funds
- 13 related to the processes and activities identified by the council.
- 14 The report shall also include an overview of the activities
- 15 identified for the succeeding year. The council shall submit this
- 16 report to the state transportation commission, the legislature, and
- 17 the transportation committees of the house and senate by May 2 of

- 19 (18) A LOCAL ROAD AGENCY MAY SEEK AND USE FEDERAL GRANTS OR
- 20 LOANS TO ACHIEVE THE GOALS AND MANAGE THE ASSET INVENTORY DESCRIBED
- 21 IN ITS ASSET MANAGEMENT PLAN.
- 22 Enacting section 1. This amendatory act takes effect 90 days
- 23 after the date it is enacted into law.
