- 1 SEC. 110A. (1) BEGINNING IN THE FISCAL YEAR THAT ENDS
- 2 SEPTEMBER 30, 2019, AND ANNUALLY AFTER THAT, THE DEPARTMENT SHALL
- 3 ALLOCATE NOT LESS THAN \$26,000,000.00 OF ITS GENERAL FUND
- 4 APPROPRIATION TO A RURAL HOSPITAL ACCESS POOL TO ASSIST SOLE
- 5 COMMUNITY HOSPITALS, CRITICAL ACCESS HOSPITALS, AND RURAL HOSPITALS
- 6 WITH PROVIDING SERVICES TO LOW-INCOME RESIDENTS.
- 7 (2) ALL OF THE FOLLOWING APPLY TO A PAYMENT FROM THE RURAL

- 2 (C) "RURAL HOSPITAL" MEANS A HOSPITAL THAT MEETS BOTH OF THE

- 4 (i) HAS 50 OR FEWER STAFFED BEDS.
- 5 (ii) IS LOCATED WITHIN A COUNTY WITH A POPULATION OF NOT MORE
- 6 THAN 165,000 AND WITHIN A CITY, VILLAGE, OR TOWNSHIP WITH A
- 7 POPULATION OF NOT MORE THAN 15,000 BASED ON THE 2010 FEDERAL
- 8 DECENNIAL CENSUS.
- 9 (D) "SOLE COMMUNITY HOSPITAL" MEANS A HOSPITAL CLASSIFIED AS A
- 10 SOLE COMMUNITY HOSPITAL UNDER 42 CFR 412.92.
- 11 Enacting section 1. This amendatory act takes effect 90 days
- 12 after the date it is enacted into law.
